3. I understand that if I am accepted as a Potential Candidate it does not automatically mean that I will be the ward candidate for my preferred ward.
4. If I am accepted as Potential Candidate it will be expected of me to:
 - Be an active (paid up) member of the Party;
 - Be a member of the branch in the ward where I live;
 - To establish a branch if there is not one in the ward;
 - To do canvassing for the Party; &
 - To actively participate in the Party's election programme and activities in the municipality where I live.
5. I understand that my work as Potential Candidate will be adjudicated and together with a written test, interview and democratic process it will determine my ward candidacy and placement on the proportional list.
